#### a. Purchase Requests

- I have attached the requests for a resolution for your review and consideration from Chief Cumo as follows:
  - Payment of \$94,280.79 for the 50% payment to VirTra for the new training simulator. This money will be taken from the Drug Forfeiture account and will be reimbursed in full, once the PCCD De-escalation Grant funds are disbursed.
  - Payment of \$1,500.00 to All Traffic Solutions for the 1-year software renewal
    used to operate the mobile traffic sign, which is used to deter speeding, promote
    upcoming events, and announce road closures. This payment will be made from
    the Police Equipment line item and then added into the Service Agreements line
    item in next year's budget.
  - Purchase of 3 new desktop computers from Compuging at a total cost of \$3,794.90. These new computers will be used to replace the aging computers used in the Police Report Room. This purchase will be paid out of the Police Computer Maintenance line item, which was budgeted at \$3,800.00 specifically for this purpose.
  - Purchase of a new Police K-9 dog and training costs. The K-9 cost is \$11,000.00, the K-9/Officer 5-week training cost is \$3,500.00, and the K-9 Farm Housing cost is \$500.00; for a total amount of \$15,000.00. This payment will be made using totally donated K-9 funds.
  - K-9 vehicle upfitting costs totaling \$9,525.00. The vehicle will be taken from our current fleet. This payment will be made using the City's designated K-9 funds.
- I have attached the requests for a resolution for your review and consideration from Chief Kobbe as follows:
  - Purchase of Motorola Minitor VI pagers for new hires from BearCom (Co-stars pricing) in the amount of \$2,182.00 and will be paid from the fire equipment line item.
