






### **ZONING/HISTORY**

The Central Building located at 101 South Mercer Street is zoned C-2 Central Business District and is the location where DON RECOVERY Services is looking to operate.

It is located close to the Lawrence County Drug & Alcohol Commission. And, is the same location that Highland House had offered out-patient drug and alcohol services. Additionally, the Central Building was also the site of other professional services such as medical offices and legal offices.

In 2009, Highland House, a drug and alcohol treatment provider, offered out-patient services at the Central Building. In August of that year, New Castle Planning Commission recommended amending the zoning ordinance to allow Highland to consolidate all its services, including residential, at the Central Building.

However in October of 2009 New Castle City Council denied the conditional zoning to add Highland House's residential services at the Central Building.

In March of 2013, a conditional zoning use request was granted by the New Castle Planning Commission to allow New Horizons Treatment Center, also a Drug and Alcohol Treatment provider to operate in Washington Center, also zoned C-2 central business district. As of May, 2019 New Horizons is still offering Drug and Alcohol Treatment in the heart of downtown.

As of May 17, 2019 the New Castle News reported that permission has been granted to Accessible Recovery Services (ARS) located at 125 East North Street, to continue servicing their clients until a conditional use permit is requested.

Services that are offered by these three (3) Drug and Alcohol Treatment centers are as follows:

Highland House: In-patient residential for women, non-hospital, drug-free services;
New Horizons Treatment Center: Out-patient counseling only; and
Accessible Recovery Services: provides MAT (Medication Assisted Treatment —
Buprenorphine, vivitrol and sublocade (injectable buprenorphine)
without counseling services.

Drug & Alcohol services in New Castle are also provided by: White Deer Run, offering the same services as New Horizons — out-patient counseling only; and Discovery House (Union Township) which is strictly a methadone clinic.

Although these single-service treatment facilities are operating within or around the City of New Castle, the needs of our community are not being adequately served.

### THE NEED

In March, 2019 the Community Assessment for Lawrence County, Pennsylvania was published. The report found that:

Lawrence County has the 12th highest rate of overdose deaths per 100,000 people. Our birthing facilities reported 15 births of babies exposed to drugs and alcohol per 1,000 newborn stays. (Assessment, page 80.)

On January 11, 2018 the Beaver County Times reported:

Lawrence County's overdose death rate is significantly higher than the rate statewide, which is 36.5 deaths per 100,000. According to data from the Center for Disease Control, the overdose death rate per 100,00 residents for the United States is estimated at 19.8.

In September 2018 the Joint Intelligence Report was published by the DEA Philadelphia Division and found that Pennsylvania's drug death numbers exceeds the national average of 22 per 100,000 in 2017.

Mental illness is common among those who struggle with substance abuse and addiction.

A study published in 2017 by the Substance Abuse and Mental Health Services Administration estimated that of 8.2 million who suffer co-occurring mental health issues with substance abuse addiction only 6.9% received the mental health and substance abuse treatment needed.

According to the National Survey on Drug Use and Health (NSDUH) 45% of those suffering with addiction have co-occurring mental health disorders.

The study also found that a multi-disciplinary approach to treating addiction and underlying mental health and/or emotional issues have resulted in documented progress in treatment and established a model for implementing strategies and achieving success in combating opioid addiction.

Thus, a program that addresses both addiction and co-occurring mental/emotional health issues truly addresses the needs of those afflicted and improves the community as a whole.

As of May, 2019 only *one* drug treatment program in Lawrence County addresses both addiction and the issue of mental / emotional health: The Lawrence County Treatment Court. However, the only individuals who have access to this program are those involved in the Criminal Justice system. Thus, unless an individual suffering addiction commits a criminal offense the demonstrated most successful form of addiction treatment is denied them.

The success of the Lawrence County Treatment court continues to be praised within the Community, yet that level of treatment and success is denied to the general public.

The County need and treatment recommendations within Lawrence County are determined by a Single County Authority (SCA). In Lawrence County the SCA is the Lawrence County Drug and Alcohol Commission. LCD&A was appointed as the SCA by the Lawrence County Commissioners.

SCAs are essentially the gatekeeper for Medicaid (Value Behavior Health) payments to the county drug and alcohol treatment providers within their county. They are tasked with contracting with providers to pay for treatment for those without insurance coverage until coverage can be secured. SCAs are then reimbursed by insurance carriers for treatment payments they advanced. The SCA will only refer individuals to treatment providers with whom they contract.

As such, SCAs control the number of treatment providers with whom they contract and ultimately through those contracts determine what addiction treatment services are offered within their county.

Presently, according to LCD&A website, they presently contract with the following drug and alcohol treatment providers *in Lawrence County:* Community Alternatives; Highland House; New Horizons Treatment Center and White Deer Run.

Yet the Pennsylvania Department of Drug and Alcohol Providers on their website list six (6) Lawrence County drug and alcohol treatment providers: Freedom Healthcare Services in Ellwood City; Community Alternatives; Discovery House (methadone); New Horizons; Highland House; and White Deer Run. None of which offer multi-disciplinary; multi-dimensional treatment programs.

SCAs fall under the purview of the Pennsylvania Department of Drug and Alcohol Programs (DDAP). Their mission is to promote recovery in conjunction with the SCAs. SCAs are tasked with the development of a service delivery system in response to community needs. (DDAP Treatment Manual, July 1, 2015-June 30, 2020.)

Provisions of the DDAP Treatment manual dictate under Section 6.00, subsection 1 that:

"The SCA must enter into a fee-for-service contract with at least two providers for each service activity in the full continuum of care." Whereas, subsection 2 continues that the SCA "shall contract with two approved Medication Assisted Treatment (MAT) providers and refer individuals for its services as indicated by the American Society of Addiction Medicine (ASAM)." Upon review of the providers in whom LCD&A contracts within the County, this mandate is not being met.

Further, the Commonwealth of Pennsylvania Department of Auditor General published the *Performance Audit Report* — *Opioid Treatment Audits* in July of 2017. At pages 11-12 the Auditor General specifically found that Lawrence County failed to offer services through MAT (medically assisted treatment) providers, only providing access to methadone treatment. "Therefore, the lack of other MAT choices in these counties leaves their populations underserved by all possible effective treatments." (pg. 11.)

The drug and alcohol treatment needs of Lawrence County, specifically the multi-disciplinary, multi-dimensional approach as recommended, is not being offered to the Community in general. The recommended model of treatment in Lawrence County is only offered to those facing criminal charges.

DON RECOVERY Services is prepared to meet that need.

### THE LOCATION

The CENTRAL BUILDING is the ideal location of DON RECOVERY Services for several reasons.

The services in which DON RECOVERY Services seeks to offer has historically been provided at that location. Thus, we are not seeking to change what has been.

DON owns the Central Building. Rents and fees paid by DON RECOVERY Services to DON Enterprise, Inc., a private non-profit organization, will, after costs, be resourced back into the non-profit to support services provided to the consumer and community based improvement projects.

The Central Building, despite the zoning, is not located in the heart of the city, unlike New Horizons Treatment Center, but is situate on a side street.

It is located in close proximity to Lawrence County Drug and Alcohol Commission and its Kaufmann's Corners, a social gathering place for those in recovery.

The Central Building historically has housed out-patient drug and alcohol services (Highland House). Additionally, professional offices such as attorneys; physicians; governmental offices; and service providers (PARC, Office of Vital Statistics, etc.) have had their offices within the Central Building. Thus, it appears that the historical use of the Central Building is consistent with the services to be offered to the Community by DON RECOVERY Services.

Although not on the main street, the Central Building is easily accessible. A number of individuals seeking treatment for addiction and/or co-occurring disorders do not have access to dependable transportation. South Mercer Street is easily in walking distance from downtown locations and bus stops, thus adverse weather conditions will not prove a deterrent to attending scheduled treatment appointments.

Lastly, its location, South Mercer Street, provides a straightforwardness in security monitoring and limiting foot traffic in and around DON RECOVERY Services and deters loitering in the area.

### **DON RECOVERY Services**

Provides a multi-dimensional, multi-disciplinary treatment approach to addiction treatment. We are dedicated to providing individuals with the tools, resources and direction necessary to achieve and maintain wellness.

DON RECOVERY has adopted and expanded upon the treatment approach utilized within the Lawrence County Treatment Court — bringing the recommended and successful approach to the treatment of drug and alcohol addiction with co-occurring mental/emotional health issues.

Whether the mental/emotional health issues existed prior to addiction; developed concurrent with the substance abuse or is a result of the addiction and the turmoil addiction causes; treating addiction without addressing the mental/emotional health issues limits treatment focus and disregards the individual as a whole.

Just as addiction effects the physical and mental health of the individual, addiction also harms family relationships, social, educational, employment, and housing factors in the individual's life. Without providing tools to improve or alleviate the strains in each of these areas, success is hard to maintain. DON RECOVERY Services in addition to providing the core addiction treatment also offers services addressing these ancillary issues.

### **Our Approach**

Begins with a professional staff.

Our Medical Director/Physician is licensed within the Commonwealth and a Certified MAT provider. Our Nurse/Practitioner also certified, supports and supplements the Medical Director.

A team of counselors: MAT certified Addiction Counselors; Peer Specialists; and our contracted consultant licensed Psychologist makes up our professional team.

Individuals who are committed to make a change in their lives — those willing to voluntarily subscribe to our structured and rigorous program — begin with a general intake interview. After a full explanation of our treatment options are presented, a medical exam is conducted. Next the multi-dimensional assessment is conducted to obtain an initial introduction to the individual: their substance use; physical health; mental and emotional health; family and home life; educational and work experience; living situation; transportation issues; and what their personal goals are in seeking treatment. Additionally, the mental/emotional health assessment is conducted.

With the completion of the medical examination and the multi-dimensional and mental/emotional health assessments, the entire professional team meets and works together to develop an individualized treatment plan.

### **Medication Assisted Treatment**

If an individual chooses the Medication Assisted Treatment path to recovery; they will undergo a four (4) phase MAT program.

It should be noted that no medication is maintained on the premises and no written prescriptions are issued by the doctor/nurse practitioner directly to the individual. All prescriptions are electronically submitted to the individual's pharmacy. In fact, as of October 24, 2019 all controlled substance prescriptions must be electronically prescribed in Pennsylvania (HB 353).

The program begins with medically monitored initiation of the treatment; followed by a period of stabilization and then the maintenance phase. During this period medical determines the minimal, yet effective, dosage of the buprenorphine/naloxone to alleviate withdrawal and cravings associated with substance abuse.

All individuals within the MAT Treatment path are medically monitored and counseled throughout each phase of treatment.

It has been found in the alleviation of the symptoms of withdrawal/cravings a fuller assessment and targeting of issues can be made and the ability to focus and commit to the treatment requirements can be increased.

All during the MAT treatment, in addition to addiction counseling, specialized MAT counseling is added to their treatment plan.

The last phase of MAT Treatment involves the tapering. Once the individual been successful in meeting the treatment plan requirements, medical will gradually taper the buprenorphine/naloxone dosage until the individual can sustain drug free.

### Mental/Emotional

Studies have shown and experience with the Lawrence County Treatment Court has demonstrated, that mental/emotional issues are often co-occurring with addiction. Whether these issues drew the individual to abusing controlled substances; developed during the use of the controlled substances or resulted because of the damage addiction causes to the individual and those surrounding them; a mental/emotional health assessment is included within the multi-dimensional assessment. This assessment and the recommendations by the psychologist are included and are a key part of the individual's treatment plan.

### **Addiction Counseling**

Central to the treatment plan is addiction counseling. Whether intensive out-patient that consists of a minimum of nine (9) hours a week or standard out-patient counseling (as they progress) to meeting with the counselor a minimum of four (4) hours per month; these sessions are key to educating, increasing their awareness and creating a tool box of resources and support to develop the confidence to achieve wellness and live a full and healthy lifestyle. And, peer support specialists supplement and reinforce these components outside the structured counseling setting.

### **Ancillary Services**

Implementation of the core treatment programs is just the starting point in treatment with DON RECOVERY Services.

Part of the individual's initial assessment includes the consequences of addiction as it effects family relationships; child/parenting issues; educational, vocational, and employment status; transportation issues and housing.

Just as addiction damages each aspect in an individual's life; healing and achieving wellness must include steps to repair each factor affected.

Through DON's affiliates, DON RECOVERY Services is able to include within the individual treatment plans specialized counseling and/or referrals through affiliates to address family/child care needs. We can offer programs, again either directly or through our affiliates to address educational needs whether that is support and tutoring to achieve a GED or assistance in preparing the application to a vocational or college-level school. We will work with the individual in meeting transportation issues and can assist in helping the individual obtain a driver's license. DON also offers employment services.

DON RECOVERY through DON affiliates is also in the process of offering transitional housing options. DON RECOVERY Services believes that individual responsibility and accountability is key in building the strength and confidence necessary to achieve a sober, stable, full and happy life. As such, our focus is developing transitional housing options (not group homes) where the individual is responsible for the rent, utilities and everyday housekeeping — thus reinforcing necessary life skills.

These services are implemented as needed while the individual is still in treatment so the support network built continues to aid in individual successes.

### Accountability

DON RECOVERY Services is created for those serious and committed to recovery. Individuals voluntarily choose the treatment program. Our treatment programs are rigorous and structured. We understand that relapses occur and we will reassess and modify treatment plans to address issues that may arise during treatment. But, we expect those within our program to have the same determination and drive to achieve wellness as we dedicate to their treatment needs. As such, several measures to ensure compliance are built within the program.

For example, all individuals within our Treatment program, regardless of treatment path are required to submit to drug screening. These drug tests are conducted both on a scheduled basis and randomly. Drug screens are conducted on site through our certified lab technician using Siemens Viva-ProE System allowing for diagnostics of up to twelve (12) reagents per sample.

Certification for this system of urine screening is approved through SAMHSA (the Substance Abuse and Mental Health Services Administration).

However, if concerns arise regarding the adulteration or attempted adulteration of a urine sample, DON RECOVERY also has the option to utilize alternative screening such as saliva or hair samples.

Diversion is always a concern especially with those involved in the medication assisted treatment program. As such, random medication counts are conducted. Additionally, (through cooperative agreements and executed consents/releases) participating pharmacies will provide DON RECOVERY with lot numbers and fill dates of all buprenorphine/naloxone prescriptions for those within our program. Random checks not only involve the buprenorphine/naloxone levels within the individual's system at any given time; but random medication counts and comparisons provide additional scrutiny.

Individuals within the program are required to promptly attend and participate in all appointments, counseling or services scheduled.

And, those enjoying transitional housing through DON RECOVERY understand that random visits by Peer Specialists may occur to check on their progress and may conduct random medication counts.

All these factors, plus others not addressed here, are clearly spelled out for all those seeking treatment with us. When an individual chooses to treat with DON RECOVERY, it's a commitment.

### Security

Those being treated with DON RECOVERY Services are assured that their privacy is protected. Confidentiality is essential to trust in treatment.

Security plans are in place to ensure that staff and those receiving treatment are within a safe and secure environment.

As previously touched upon, several checks and balances are instituted to detect and deter the diversion of medication.

However, DON RECOVERY Services also has a commitment to the Community.

To alleviate community concerns we have installed security cameras to monitor the areas surrounding the Central Building, the sidewalks in front of the building and all parking lots. All access doors are secured and entrance into the treatment center is secured. Again, no medications are maintained on the premises and no individual leaves the facility with a prescription for MAT, all treatment prescriptions are electronically issued to the pharmacy.

Each person choosing to treat with DON RECOVERY Services is made aware; must understand; and agree to a code of conduct. We are committed to helping those who want to help themselves become responsible and productive members of the community. Accountability and personal responsibility is principal to wellness.

### The Community

Just as DON RECOVERY Services reaches out and collaborates with DON and its affiliates and the community as a whole, we will not deny our services to other treatment providers who wish to expand services to their clients.

DON RECOVERY Services will work with those whose goals are the same as ours: helping those afflicted by addiction and/or co-occurring disorders to achieve wellness. Whether it is adding our strictly monitored MAT treatment to their treatment program or if outside agencies wish to utilize our drug screening capabilities, DON RECOVERY will collaborate with those providers or agencies.

Those at DON RECOVERY Services have been blessed with the experience and training to see what a collaborative and cooperative treatment program can do in assisting individuals in regaining their life, rebuilding their families and contributing to their communities through employment.

A community is made of individuals.

Healthy and productive individuals enhance and grow the community.

DON RECOVERY Services has a commitment to the individual and the community.

### Conclusion

DON RECOVERY Services is not asking to change or modify the traditional and historical use of the Central Building. We are asking to offer the needed services at a convenient and centralized location where such services were once offered.

In this proposal we have briefly summarized the mission of DON RECOVERY Services, the treatment paths offered. We have assured that no medication will be stored on premises, nor will prescriptions be issued directly to those seeking treatment. And we have briefly summarized the rigors and the structured nature of our treatment program.

We discussed a few of the diversionary reduction programs we have instituted as well as safety provisions not only for the staff and individuals being treated, but also to the building and surrounding property.

Lastly, we extend our services to those other treatment providers who wish to enhance services to their clients and other agencies within the community where we may offer service.

### **Chris Miller**

While I do not support the concept of non-commercial activities in the downtown business area; I feel that there is definitely a need for the proposed services in an area served by public transportation providers. To me, this need takes precedence. I vote for granting the conditional use.

### **Dave Esposito**

I have given the Don Recovery appeal a lot of thought and have carefully reviewed the Power Point presentation prepared by Don Services as well as their answers to the question posed to them. I would have liked to have had public input but that was unachievable given the City's technological limitations. I am especially interested in comments, if any, from neighboring property owners. I am sad to say that it appears, from the interest in downtown properties, the highest and best use for central business district properties is not for profit, social service uses. I would be delighted to have an appeal to review that was a for profit commercial use but alas that is not what we see before us. I can't help but think as more social service uses are located downtown, the area will continue to be less attractive to other commercial uses.

If this region is to support a vibrant city center there has to be a complete change of mindset for all parties including the townships accepting more responsibility to host regional social services and affordable public housing. Currently, the City bears the responsibility of hosting these very important uses while the townships continue to siphon the remaining commercial uses out of the City.

My vote is to approve Don Recovery's request for conditional use, as other members have said in their statements, the use is not ideal for the central business district but needed to Lawrence County. I just wish the location of Don Recovery would not be in the Central Business District.



Response to Mr. Miller's questions:

- 1. Yes, there are other tenants within the building presently and others in the process of remodeling their spaces to open.
  - a) DON Insurance (Suite 104); Career Link (Suite 101); Learning Center (Suite 201)
  - b) Each tenant has separate access to their businesses
    - I. It is understood that the Conditional Use request is only applicable to DON Recovery Services, which will be located in Suite 105.
- 2. DON Recovery Services has its own direct access from the street, none of the consumers will be within the common areas of the other tenants; additionally the designated smoking area is located at the side entrance from the parking lot, and this area is separated from the other tenants. Again, the main entrance is secured and only those consumers with an appointment or business with DON Recovery Services are permitted into the waiting area. This area is protected by buzzer and video link. Consumer's identities are verified before entry is permitted and they are buzzed into the waiting area.
- 3. DON Recovery Services possesses an occupancy permit from the state and is compliant with the 2015 building code.
  - a) Additionally, DON Recovery Services, pursuant to State Licensing requirements, is inspected yearly by the Commonwealth, thereby ensuring all safety and security procedures are compliant. For example: all fire extinguishers are inspected yearly; fire and medical emergency drills are conducted monthly and results are logged; emergency exit routes are posted in each office; and so on.
  - b) All staff members are trained and take part in the monthly emergency drills.
- 4. DON Insurance (Suite 104) has been in the building for over a year; Career Link (Suite 101) is in the process of remodeling their space and the Learning Center (Suite 201) is in the process of remodeling their space for occupancy.
  - a) As an aside, Ms. Shaffer and Mr. Hower met with the Board of Directors of the Learning Center and a cooperative and working relationship between the agencies has been established. Moreover, Career Link's officers are likewise aware of the impending opening of DON Recovery Services and have expressed no reservations.
- 5. Yes, DON Recovery does not store, dispense nor administer buprenorphine (Suboxone) on the premises.
  - a) The consumer choosing the MAT (buprenorphine) program may on occasion be required to bring their unused prescription and strip wrappers (they are required to retain all of the used wrappers of the Suboxone strips) for random medication counts and to ensure they are using the prescription as prescribed and ensuring

no diversion. This random check is done in addition to random checks conducted at their home by our peer support staff members. Requiring a consumer to bring in their unused prescriptions is done only where there is strong suspicious of diversion or misuse.

- 6. Yes, unfortunately there is a street market for buprenorphine, just as with any other controlled substances. That is why tight regulations and monitoring provisions will be instituted, including the random prescription counts as set forth above; requiring the release/consents signed with the consumer's pharmacy to notify DON Recovery Services of the date and quantity their prescriptions are filled; and in-house laboratory drug screening of consumers is conducted, to name of few of the regulations and monitoring provisions being utilized. Any suspicion or proof of diversion is a basis for at a minimum modification of their treatment program up to the expulsion from the treatment program for serious or continued misuse or diversion of their prescriptions. DON Recovery Services is designed to treat addiction and those who are not serious about addressing their addiction will not be tolerated. We understand that set-backs may and will occur during a consumer's treatment program, however, the diversion of medication will not be tolerated under any circumstance.
- 7. The hours of intended operation are Monday, Tuesday and Thursday 8:30 a.m. to 4:30 p.m.; Wednesday 8:30 a.m. to 6:30 p.m. and Friday 8:30 a.m. to 2:30 p.m.
- 8. Any consumer arriving for an appointment visibly impaired will not be treated. Depending upon the severity of their impairment a family member or emergency contact will be notified to pick them up and transport them home; if they are seriously impaired and their health is in jeopardy an ambulance or EMT will be notified based upon the advice of the medical staff. If medical intervention is not needed and if staff cannot contact their family member or emergency contact, DON Recovery Services will ensure that consumer's safety by utilizing a peer support staff member. Their appointment will be re-scheduled and a team meeting will be scheduled to discuss and modify their treatment program or to recommend admission to (and successful completion of) an in-patient program before continuation of their outpatient treatment.
- g. The number of consumers present at the facility will be based on the number of appointments scheduled for that day. No person will be permitted except those with an appointment or those present to schedule an appointment. As previously indicated, only those individuals having business or an appointment are admitted to the premises. Loitering or congregating will not be tolerated. However, several consumers may be scheduled during the same time period based upon their appointment, for example: a consumer may be scheduled for a medical follow-up; counseling with the psychologist; an appointment with a drug and alcohol counselor or a group session. However, all persons present will be there for at a specific time and for a specific time period, and generally by appointment only.

- 10. The parking area for DON Recovery Services is specific for the office and is located directly next to the entrance and is adequate to allow parking for those attending sessions. DON Recovery's parking area is located on the south side of the building, between the building and the bridge. The parking lot can allow for the parking of \_\_\_\_\_\_ cars and is monitored with security cameras and is well lighted.
  - a) All staff have access to the parking garage for parking and security. All automatic garage openers are issued and recorded by the building supervisor and as with all DON Recovery Services property, a signed record of the issuance and/or return of the property is maintained.
- 11. As indicated, both Career Link and the Learning Center are aware of the services offered, and are complimentary and supportive of the concept and mission of DON Recovery Services in that all are geared to improving the life of the individual whether in preparing for and establishing a career; preparing for higher education or technical schools; GED preparation and testing; and even adding English as a Second Language, all services are a part of treating the consumer as an individual and obtaining the specialized services to improve their standing in the community and overcoming addiction and being a part of the recovery community. Moreover, several meeting have been held with several adjacent business owners to appraise them of the program.

### 12. Yes.

- a) Our Peer Specialist has reached out and met with UPMC and the emergency department explaining our program and, once operational, an emergency contact will be established to work with those presenting at the Emergency Room.
- b) Our Peer Specialist has also reached out and met with other service providers within the community such as Children & Youth Services; the Child Advocacy Center; the Crisis Center and others whose services will be incorporated into consumer's treatment program as necessary.
- c) A meeting has been held with the Human Services Center and with the key mental health services providers within the Community and a working relationship and cooperation of services has been established.
- d) Additionally, a meeting was held with the new addiction treatment providers with the Lawrence County Jail and with the Lawrence County Commissioners establishing a cooperative working relationship to ensure a continuity of treatment to those exiting the criminal justice system.
