X. Resolutions for Consideration

a. Act 47 Grant Application

The City to apply for an Act 47 Grant in the amount of \$175,000 that would fund an economic development specialist position that would answer to the New Castle CDC with oversight from DCED. This position would be recruited and earn \$50,000 per year for the next (3) three years. In addition, this grant would be to apply for \$25,000 for a study to be done by RECAST, a group that brings a small manufacturing business approach to downtown.

b. Act 47 Grant Contract (C000073354) Amendment

This grant for the Professional/Consultant for the Home Rule Study Commission awarded the contract to Public Partners, LLC. They have exhausted the amount of the contract and would like to remove the preparation of the administrative code, if Home Rule succeeds at the ballot, of their current contract. If the City agrees to amend this current contract and home rule is enacted by the voters, PFM has allotted hours within their budget to draft the administrative code.

In addition, Public Partners, LLC has closed its operations as of 12/31/2020 and has transitioned operations to the Allegheny League of Municipalities.

c. Repair to the Bucket Truck for Electrical Department

In accordance with Article 131, Fiscal Procedures, the Public Works Director has submitted a quote for the repairs of the Bucket Truck in the approximate amount of \$2,409.00 since this amount exceeds \$1,500.
